

Terms and Conditions for Sweepstakes Conducted by Wieland Werke AG on LinkedIn

1. Organizer and Scope

The sweepstakes are organized by:

Wieland Werke AG

Graf-Arco-Straße 36

89079 Ulm

(hereinafter referred to as the “Organizer”).

These terms and conditions apply to all sweepstakes conducted on the Organizer’s official social media channels, including but not limited to:

- Wieland Group on LinkedIn

By participating in the sweepstakes, each participant acknowledges and agrees to be bound by these terms and any additional information provided in the respective social media post.

2. Eligibility

Participation is open exclusively to natural persons who:

- are at least 18 years of age,
- participate in their own name.

Excluded from participation are:

- individuals involved in the organization or execution of the sweepstakes.
- employees of Wieland and its subsidiaries

Multiple entries, automated participation methods, and participation via sweepstakes services are not permitted.

3. Sweepstakes Procedure

Participation is effected by interacting with a specific post on one of the aforementioned social media channels (e.g., by commenting), as specified in the respective sweepstakes post.

Participation is free of charge and not dependent on the purchase of any product.

The participation period stated in the post is binding. Entries submitted after the deadline will not be considered.

4. Prize and Winner Selection

The prizes specified in the respective sweepstakes post are binding. Variations in design, color, or model are possible. Cash payment, exchange, or transfer of the prize is excluded.

Winners will be selected from all valid entries. The **evaluation will take place no later than 10 calendar days** after the end of the sweepstakes.

5. Notification and Acceptance of the Prize

Winners will be notified via direct message on the respective social media platform. Additionally, winners may be publicly named (e.g., by username) in the feed or story. The publication of names is based on a voluntary consent, which is obtained as part of the winning notification. Consent has no influence on the chances of winning or the entitlement to the prize. Further information on data protection and withdrawal of your consent can be found under **9. Data protection**.

Prizes that must be collected in person must be claimed at the Organizer's location within **10 calendar days** of notification. Failure to collect the prize within this period will result in forfeiture without substitution. In the case of postal delivery, the risk of loss transfers to the recipient upon handover to the shipping provider.

6. Exclusion from Participation

The Organizer reserves the right to exclude individuals from participation if:

- these terms and conditions are violated,
- attempts at manipulation are made,
- technical tools are used for multiple entries, or
- there is reasonable suspicion of abusive behavior.

Exclusion may occur without prior notice and may also apply to already selected winners. No entitlement to participation or prize exists in such cases.

7. Modification, Interruption, and Termination

The Organizer reserves the right to terminate or modify the sweepstakes at any time for good cause. Good cause includes, in particular:

- technical or legal issues,
- manipulation or abuse,
- actions by platform operators (Linkedin) that affect the sweepstakes.

Participants shall have no claims for compensation in such cases.

8. Liability

The Organizer shall be liable without limitation for intent and gross negligence, as well as for damages resulting from injury to life, body, or health.

In the event of simple negligence in breaching essential contractual obligations, liability shall be limited to typical, foreseeable damages. Liability for slightly negligent breaches of non-essential obligations is excluded.

9. Data Protection

In the context of the sweepstakes, personal data will be processed only to the extent necessary for execution. This includes:

- for all participants: social media username,
- for winners additionally: full name and, if applicable, address (for shipping purposes).

Legal basis:

- for the public disclosure of the name: Art. 6 (1) (a) GDPR (consent)
- for the execution of the sweepstake: Art. 6 (1) (b) GDPR (performance of a contract)

The data will **not be transferred to third parties** unless this is mandatory due to legal provisions, necessary for the execution of the sweepstake (e.g., to shipping service providers), or consent has been given. The data will not be used or sold for advertising purposes and will only be used in the context of the sweepstakes.

We store the data for three years after the sweepstakes has been held. Thereafter, it will be deleted.

Data subject rights:

Participants have the right to access, rectification, erasure, restriction of processing, data portability, and objection pursuant to Art. 15–21 GDPR.

10. Governing Law, Jurisdiction, and Severability

The laws of the Federal Republic of Germany shall apply exclusively. Legal recourse to challenge the prize decision is excluded.

Where legally permissible, Ulm shall be the place of jurisdiction.

Should any provision of these terms and conditions be wholly or partially invalid or unenforceable, the validity of the remaining provisions shall remain unaffected. A legally permissible substitute provision that most closely reflects the economic intent shall apply in its place.
